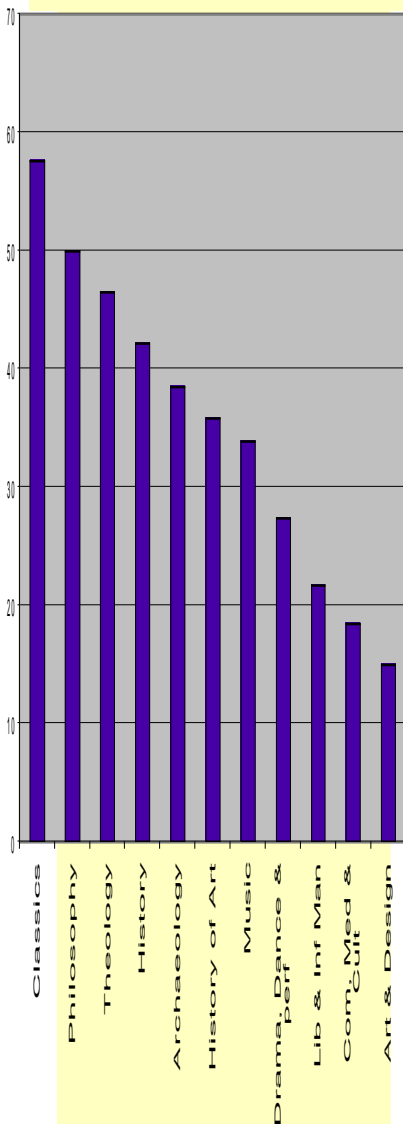

RAE Grade 5 awarded to Art and Design

In the most recent HEFCE Research Assessment Exercise conducted in 2001, Art and Design (Unit of Assessment 64) received a grade 5. This recognition of the international standing of the research work of the Faculty of Arts & Architecture embraces most areas of the Faculty's activity including the creative and performing arts & design, architecture and interior design, the history of decorative arts, design and the fine arts, together with critical and cultural studies. As well as being the University's highest volume of research active staff, it was also the sector's 5th largest submission.

Building on this success the Faculty of Arts & Architecture has undertaken to manage research activity over the next five years in a number of ways. This is outlined in the Section 5c: *Research Strategy 2001-2006* of the RAE 2001 submission.

The Faculty has committed itself to the following principles and actions:

- enhancement of mature critical debate within and across the projected (inter)disciplinary research groups
- maintenance of conditions in which the insights of individual researchers will be stimulated, liberated, supported and monitored;
- development of the research infrastructure through:
 - i) continued enhancement of the work of the Centre for Research & Development (Arts & Architecture);
 - ii) continued refinement of the support of the Research Student Division for

research student activity, attracting the highest quality doctoral programmes to the work of each research group and stimulating registrations to them;

iii) exploration of the co-ordinated research potential offered through formation of a new Graduate and Research School;

iv) development of emerging work in pedagogic research along with the first issue of a new research journal in 2002;

v) extension of the existing network of design archives to include major archival holdings in Japan and an international seminar mounted to inaugurate such work;

vi) development of research relating to the Centre for Contemporary Visual Arts, spanning the interests of the research groups, with the appointment of a new Principal Research Fellow and through curation of research-led exhibitions.

Building on the position achieved last year, the Faculty delivered a well attended, feedback session in the Sallis Benney Theatre on 27th February 2002,

and individual group meetings as outlined in the RA5 have also begun to meet with some success.

These individual research group meetings have a number of purposes:

- to address the realities of the RAE 2001 RA5 Submission for the Research Group;
- to consider the scope and future possibilities for interdisciplinary research within the definitions of individual research groups;
- to consider inviting leading scholars to dedicated research workshops;
- to contemplate mechanisms for progressing interdisciplinary research.

A further priority for the remainder of this academic year is the launch of a Faculty research Website (see page 5).

Prestigious Graphic Design Archive comes to Arts & Architecture

The world's leading forum for graphic designers has chosen the Design History Research Centre (DHRC) at the University of Brighton to be the central location for its archives.

The archives of the International Council of Graphic Design Associations (Icograda) are currently scattered around several institutions, including the Design Museum in London.

The decision will bring together the work of key figures in Icograda such as its first president Willy de Mayo, who designed for the Festival of Britain; the Dutch designer and typographer Wim Crowel and FHK Henrion, who is regarded as one of the last century's most important designers.

The FHK Henrion archives and Research Library are already housed at the DHRC. The University's 2001 Christmas card featured one of Henrion's card designs, which are found in the archive.

Thierry Van Kerm, director of the Icograda Secretariat in Brussels, and a steering group overseeing the Icograda collection, have visited the DHRC's archives and were impressed by the digital and intellectual developments around its key holdings, which include those of the Design Council. The DHRC promotes research in the form of publications, exhibitions, seminars, and a wide range of projects from investigations into teaching and learning practice to artist residencies.

The decision to centralise the archives at the DHRC also follows a recent Government assessment of the Faculty's research work as being world class.

Professor Jonathan Woodham, director of the DHRC, said: 'Icograda's work and activity includes most of the leading graphic artists of the past 50 years. The archive will also include 25 years worth of international exhibition material. The council's decision to place the archive here coincided with confirmation of the international research standing of the faculty's work.'

Research Student News

The total number of registered research students is 50, with new applications being received at an ever-increasing rate.

The University is currently approving two entry dates per year for research students, (September and January) which should make the admissions procedures more streamline.

Staffing News

Sue Gollifer gave a paper at the College of Arts Conference (CAA) in Philadelphia, USA in February, on the education, segregation and integration panel-paradigms for teaching digital and other technologies.

Alma Boyes has created a life-sized statue of a cordwainer in bronze (see picture), which was unveiled in the courtyard of St Mary Le Bow Church in Cheapside, London in February this year. This was in commemoration of the club's centenary. A cordwainer was a shoemaker and leatherworker from 13th century, and the sculpture depicts a cordwainer at work.

Catherine Moriarty is undertaking research for a book on Games to be published by Lund Humphries and Princeton University Press, to coincide with an exhibition at the Design Museum in 2003. Catherine has been invited by the Henry Moore Institute to contribute an essay on the sculptor Robert Adams to a forthcoming volume based on the Leeds sculpture collection. In addition, Catherine is presenting a paper at the conference 'Drapery and Visual Culture: Contexts, Clothing and Corporealities' at the National Gallery, 30th-31st August 2002.

Professor Michael Tucker curated the exhibition *'Mayo Bucher: Open Sign'* which was shown at the University of Brighton Gallery in March and April and which will travel to Leipzig in November 2002. Michael contributed an essay to the book *'Mayo Bucher: Open Sign'* which accompanied the exhibition and which will be distributed in Europe and America by Lars Mueller Publishers, Baden. Professor Tucker has also arranged the two events which complemented the exhibition, a gallery talk with the artist and a cello concert by the world-renowned ECM recording artists Patrick and Thomas Demenga.

Professor Tucker has written articles on contemporary Norwegian graphics (to be published in the next edition of *'Printmaking Today'*) and contemporary Norwegian music (to be published in the next edition of *'Avant'*). He has been invited to review the fiftieth anniversary of the Bergen Festival in May, one of the major events in the Norwegian cultural calendar.

Mary Anne Francis is exhibiting new work as part of E1 Gallery's group show in London 1st-30th May.

Jonathan Woodham is a member of the International Advisory Board for the Third International Conference on Design History and Design Studies to be held in Istanbul from July from 9 to 12 July 2002. Entitled *Mind the Map: Design History beyond Borders*, this follows two earlier international conferences in Barcelona and Havana in 1999 and 2000 that sought to extend debates about the significance of the history of design across the Spanish-speaking world. Jonathan Woodham is co-chairing a strand entitled 'Design History Narratives: Local, National or Global' and will be contributing a paper that explores such issues from a British perspective. Amongst the keynote speakers at this conference (which is supported by the British Council) will be Professor Tim Benton. He will be presenting a paper about researching and redefining Art Deco from a national and global perspective in respect of the large Art Deco Exhibition to be mounted at the V&A in 2003 (for which Jonathan Woodham has contributed a catalogue essay).

Kiss & Kill: Film Visions of Brighton

SEFVA initiated this exhibition in 1999, and after a number of delays it finally opens in May 2002. This new exhibition at the museum explores the many feature films which have been made in the city from the 1930s onwards, as well as amateur and professional material from the archives collection. Particular emphasis is placed on Richard Attenborough and his two key Brighton films: *'Brighton Rock'* and *'Oh What a Lovely War'*. Access to his personal archive formed a significant part of the exhibition research. In addition, a catalogue accompanies the exhibition with a number of essays on relevant themes. Also, an interview with Richard Attenborough, in the accompanying events leaflet, describes the programme of talks, study days and screenings which run from May until July. The exhibition is being held at Brighton Museum and Art Gallery and runs from 4th May until 1st September 2002.

New Research Website

Subsequent to our success in achieving a Grade 5 in the RAE, the Faculty will be launching in September 2002 a research website to profile what is now perceived to be a research environment of 'international excellence'. The Centre for Research and Development has recently appointed leading web-design company "Nykris" to develop, design and launch the new Faculty Research Website. One purpose of this website is to affirm that research through creative practice leads to new areas of knowledge of equal standing to similar endeavours in the natural sciences.

A further intention is that this website will help persuade the research councils and other stakeholders that research in art and design is a mainstream activity in general and specifically at the University of Brighton. Overall, the site should represent to visitors a leading research area of substantial breadth and depth in the creative and performing arts and design.

Nykris have previously worked with Microsoft, The Tate Gallery, The Government Art Collection and The Smithsonian Institute, Washington.

Faculty Research Support Awards

Congratulations to **Sue Gollifer** who was awarded £500 for her "Opposite Corners" project. The "Opposite Corners" group enables mature artists to work in media, not usually available to them, and Sue will be working with 'Escol' a company based in Wellingborough, Northants, to produce three large Enamel panels. These panels will be designed for external architectural use, and are characteristic in having strong, clear colours. This project is also supported by the Regional Arts Lottery Project.

CCVA to Curate Canadian Sculpture Exhibition

Barry Barker (Principal Research Fellow in the Centre Contemporary Visual Arts) has been invited to curate an open air exhibition of British Sculpture for the city of Vancouver , Canada. The exhibition will include large scale works by some of Britains leading sculptors including Tony Cragg, Anthony Gormley, Richard Deacon and Anish Kapoor.

The exhibition which is scheduled to open this summer and continue through to the autumn will also include an international conference on Contemporary Sculpture. This exhibition is a collaboration with the University of Brighton, the Yorkshire Sculpture Park, the City of Vancouver Art Gallery, the University of British Columbia, and the Emily Carr Institute.

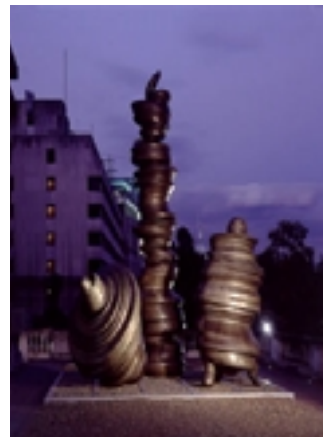

- **AHRB Research Leave Scheme - Increase in funding**

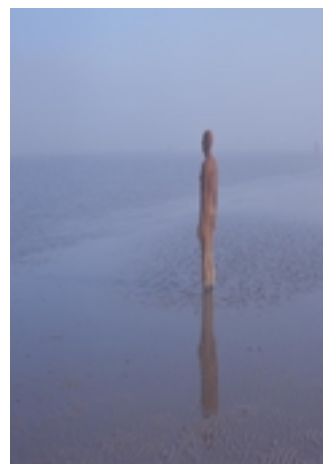
In partnership with the employing institution, the AHRB Research Leave scheme enables an individual scholar to be relieved from all teaching and administrative duties in order that a significant research project may be completed within the six or eight month period of an award. Last Autumn, the AHRB re-launched its Research Leave scheme to fund replacement teaching costs for periods of research leave of three or four months, rather than funding the applicant's own salary costs.

The AHRB has reviewed this revision to the scheme, paying careful attention to the comments of the higher education institutions and individual researchers.

As a result of this internal review, the Board is pleased to announce that the Research Leave scheme will now fund full replacement teaching costs, including the on-costs of national insurance and superannuation, with a 46 percent overhead contribution attached to all awards. Consequently, the revised award values (inclusive of a 46% overhead contribution) will be:

3 month, non-London HEI	£9,026
3 month, London HEI	£9,984
4 month, non-London HEI	£12,035
4 month, London HEI	£13,311

All documentation for the AHRB Research Leave scheme will be reviewed over the Summer, and an updated Guide to the Research Leave scheme and application form will be published in September 2002.
